it should only be noted with regard to the statements of the discerning senate in its communication of 24.3.2022, there in the 1st paragraph on page 2, that we can of course also assume the allegations on which the data analyst Tom Lausen has been appointed as an expert to be true and put them beyond dispute.

If we find the allegations of Tom Lausen, SV, undisputed, then we may hear Susanne Wagner, MD, SV, in his stead on 2/5/2022 on the evidentiary issues on which I called her as an expert witness in my brief of 4/14/2022.
